

EXPORT OF PORCINE SEMEN TO INDIA - 7451EHC

NOTES FOR GUIDANCE FOR OFFICIAL VETERINARIANS AND EXPORTERS

IMPORTANT NOTE

These notes provide guidance to Official Veterinarians (OVs) and exporters and should have been issued to you together with export certificate 7451EHC. These Notes for Guidance (NFG) are not intended to operate as a standalone document but in conjunction with certificate 7451EHC.

CERTIFICATE 7451EHC HAS NOT BEEN FORMALLY AGREED WITH THE AUTHORITIES IN THE IMPORTING COUNTRY.

Exporters are therefore strongly advised to verify the requirements of the importing country by contacting the veterinary authorities, or their representatives in the UK, in advance of each consignment. They should obtain an import permit and check this certificate against the requirements of the import permit.

If the health requirements do not match, the exporter may choose to proceed with the export using certificate 7451EHC BUT STRICTLY AT EXPORTERS RISK.

1. SCOPE OF THE CERTIFICATE

Export health certificate 7451EHC may be used for the export of fresh/frozen porcine semen from the United Kingdom to India.

Exporters and certifying official veterinarians must take particular note of the information on disclaimers at paragraph 10.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN

This certificate may be signed by a Veterinary Officer of the Department or a Local Veterinary Inspector (LVI) appointed by the Department for Environment, Food and Rural Affairs (Defra), the Scottish Government, the Welsh Government or by an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture and Rural Development, Northern Ireland (DARD), who is an Official Veterinarian (OV) on the appropriate export panel for export purposes.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

A certified copy of the completed certificate must be sent to the Animal Health and Veterinary Laboratories Agency (AHVLA) Specialist Service Centre - Exports - at Carlisle within seven days of signing, or in the case of Northern Ireland to DARD, Dundonald House, Belfast.

The OV should keep a copy for his/her own records.

3. OBTAINING AN IMPORT PERMIT

The exporter/agent should be aware of the requirements of the importing country particularly with respect to the requirement for an import permit. If required, the import permit number should be given in the health certificate at paragraph IV(d).

4. SCHEDULES

Parts I and II refer. Separate schedules may be used to identify the donor boars and porcine semen certified. Schedules must contain the same information as that required in Parts I and II. Parts I and II must be annotated "See attached schedule" as appropriate. Each page of the schedule(s) must bear a page number and the health certificate reference number and must be signed, dated and stamped by the OV.

The schedule(s) must be stapled inside the health certificate and the OV should "fan" and stamp over the pages of the schedule(s) and certificate. The top stapled corner of the schedule(s) and certificate should be folded over and stamped also. Any blank spaces in the schedule(s) or in Parts I and II must be deleted with diagonal lines.

5. COUNCIL DIRECTIVE 90/429/EEC (as amended)

The certifying Official Veterinarian must be fully conversant with the provisions of Council Directive 90/429/EEC and any subsequent amendments, laying down the animal health requirements applicable to intra-Community trade in and imports of semen of domestic animals of the porcine species.

Paragraphs VI(a), VI(d), VI(f), VI(h), VI(i) and VI(j) may be certified on the basis that the semen collection centre is approved by the Department and operating in accordance with Council Directive 90/429/EEC (as amended).

6. ORIGIN AND RESIDENCY OF DONOR BOARS

Paragraph VI(b) refers. The certifying OV should check appropriate farm and movement records to verify that the donor boars meet the UK origin and residency requirements of this paragraph.

The OV may also wish the operator of the collection centre to provide a signed statement as additional verification of origin and residency.

7. NOTIFIABLE DISEASE CLEARANCE (FORM 618NDC)

Paragraph VI(c) refers. OVs may certify this paragraph on behalf of the Department provided written authority to do so has been obtained on form 618NDC from the AHVLA Specialist Service Centre - Exports - at Carlisle or issuing office of DARD in Northern Ireland.

8. LABORATORY TESTS

Paragraph VI(g) refers. The OV must ensure that any laboratory carrying out pre-export testing is officially approved for this purpose by Defra or DARD.

In Great Britain (England, Wales and Scotland), the majority of pre-export testing is carried out at the AHVLA Laboratory, New Haw, Weybridge, Addlestone, Surrey, KT15 3NB, (Tel: 01932 341111). Some tests are carried out at VLA Lasswade, Pentlands Science Park, Bush Loan, Penicuik, Midlothian, EH26 0PZ, (Tel: 0131 445 6169). Certain specialist tests are carried out at regional AHVLA laboratories.

In Northern Ireland, the majority of pre-export testing is carried out at the Veterinary Sciences Division (VSD) Laboratory, Stormont, Belfast, BT4 3SD (tel: 028 9052 0011).

For operational reasons however, the laboratories involved may change periodically. Accordingly, the OV is advised to check with the AHVLA or VSD to determine to which laboratories samples should be sent for testing. Samples should always be sent to the laboratory concerned sufficiently in advance of the export date to enable the tests to be carried out and reported. If in doubt as to the procedures for collection, the requirement for transport medium if any, dispatch of samples and the length of time a test is likely to take, the OV should seek the advice of the relevant laboratory.

9. TUBERCULIN TESTING OF DONOR BOARS FOR EXPORT PURPOSES

Paragraph VI(g) (ii) refers. Exporters and OVs should note that tuberculin testing should not be repeated within 45 days of a previous tuberculin test. Before a pre-export test is carried out, the OV should seek confirmation that the animals to be tested have not had a previous test within that period.

Tuberculin Testing Method

The preferable site is the loose skin at the base of each ear. Each site should be cleaned, the loose skin at the base of the ear raised into a fold and the skin thickness measurement recorded. Standard strength PPD, as issued for cattle, must be used and a dose of 0.1 ml injected intra-dermally into each raised fold taking care not to inject subcutaneously.

A useful aid for subsequently reading the test is, after cleaning, to draw a circle on the skin at each selected site with a black felt-tip pen and the injections are made within the encircled areas.

Any increase in skin thickness of more than 2mm at the site of injection or any oedema, necrosis or swelling of associated lymph nodes, should be regarded as a positive reaction. If any animal has a reaction at the bovine site greater than at the avian site, the local office of the AHVLA or DARD must be informed.

10. DISCLAIMER

Exporters and certifying official veterinarians must be aware that this export health certificate, 7451EHC, takes into account the important recommendations by the World Animal Health Organisation (OIE) for trade in this commodity.

Exporters and certifying official veterinarians must also be aware that 7451EHC has not been officially agreed with India. Accordingly the exporter and the Official Veterinarian must note that use of 7451EHC for the export of porcine semen to India is used at the exporter's risk. Official veterinarians should ensure that the exporter is aware of this.

The exporter should therefore be aware that 7451EHC may not take the requirements of the importing country into account. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country if these are available. If official advice is provided by authorities in the importing country or if an import permit is provided, the exporter must copy these to the AHVLA Specialist Service Centre - Exports - at Carlisle.
