## IV. Health Information:

(a) the meat in this consignment (including raw meat preparations, meat products and mechanically recovered meat) is derived from clinically healthy animals or birds that originate from premises and administrative territories officially free from the following Notifiable diseases (as defined in the OIE Terrestrial Animal Realth Code):

- i) Notifiable Avian Influenza;
- ii) Newcastle disease;
- iii) Foot and mouth disease
- iv) African swine fever
- v) Classical swine fever
- (b) the meat in this consignment (including raw meat preparations, meat products and mechanically recovered meat) was obtained from animals or birds which were submitted to ante-mortem and post-mortem inspection under veterinary supervision and were found to be free from any evidence of infectious or contagious disease;

(c) The slaughterhouse(s), cutting plant(s), processing plant(s) and cold store(s) involved in the production and storage of the meat in this consignment were not, at the time when the meat was being handled on those premises, subject to animal health restrictions under European (EU) law due to the presence of Notifiable disease;

(d) the meat in this consignment has been dressed, prepared, packed and stored under hygienic conditions in accordance with regulations at present in force in the European Union (EU);

(e) on the basis of legislation currently in force in the European Union, it can be considered that the meat in this consignment does not contain levels exceeding the limits permitted in the European Union of any veterinary medicinal product, antiparasitic agent, heavy metal or chemical contaminant; and does not contain any beta-agonist or any substances having a thyrostatic, oestrogenic, androgenic or gestogenic action which do not occur naturally in the meat;

- (f) no meat derived from any other species apart from pigs and poultry (e.g. bovine, ovine or equine) has been included in or added to this consignment;
- (g) the meat in this consignment does not originate from any pigs or poultry slaughtered as part of a disease eradication program/measure;
- (h) the meat in this consignment is considered fit without restriction to be freely placed on the market for retail sale and for human consumption within the European Union (EU).
