f)	a written declaration has been received from the exporter stating that the said animals will be transported direct from the premises or origin to the approved isolation premises in a vehicle cleansed and disinfected with a DEFRA approved disinfectant before use, without coming into contact with animals other than those similarly certified, and will not travel through any area declared to be infected with foot and mouth disease and classical swine fever.

2. Approved Isolation Premises

I, the undersigned, certify that the animals described above meet the following requirements:

- a) the said animals have been held in approved isolation premises under my supervision and have not come into contact with any animals which are infected with Brucellosis, Leptospirosis, Porcine Reproductive and Respiratory Syndrome (PRRS), Transmissible Gastro-enteritis (TGE), Aujeszky's disease, Atrophic Rhinitis, Enterovirus Encephalomyelitis (Teschen disease), Swine Erysipelas, Swine Dysentery (Campylobacter) or Post Weaning Multisystemic Wasting Syndrome (PMWS) during the past 30 days;
- b) the isolation premises is not subject to any official restriction for the control of diseases to which pigs are susceptible;
- c) on(date), being within 30 days of the date of export, blood samples were taken from the said animals and sent to a Veterinary Laboratory Agency laboratory, where they were subjected to the following tests with negative results in each case:-
 - (i) a serum agglutination test for brucellosis (negative means less than 30 iu/ml);
 - (ii) an enzyme linked immunosorbent assay (ELISA) for Aujeszky's
 disease;
- (d) on(date), being not less than 14 days after the commencement of isolation, blood samples were taken from:
 - **EITHER** *(i) the entire herd if 12 pigs or less;
 - OR *(ii) 12 randomly selected individuals of any consignment of less than 120 pigs in isolation;
 - OR *(iii) a randomly selected 10% of any consignment over 120 pigs in isolation;

and tested for antibodies to porcine reproductive and respiratory syndrome virus using the immunoperoxidase monolayer assay with negative results in each case;

3. Official Disease Clearances

- a) Great Britain has been free of swine vesicular disease during the past 2 years;
- b) Great Britain is free of foot and mouth disease and classical swine fever in accordance with the OIE International Animal Health Code;
- c) African Swine Fever has not occurred in Great Britain

4. Transport Arrangements

A declaration has been received from the * exporter/* representative of the company in charge of the transportation of the consignment to the Philippines, stating that;

- (i) no animals or other ruminants shall be permitted aboard the vessel or aircraft from another country during the time when the pigs are on board;
- (ii) no fodder, feed or straw shall be taken on board from any intermediate port during the time the pigs are on board the vessel or aircraft.
- V. This certificate is valid for a period of 15 days from the date of signature. If the consignment is transported from the country of origin by sea, the period of validity is extended by the duration of the voyage.
