IV. Health Information

- I, the undersigned, certify that:
- the United Kingdom (UK) is recognised by the Office International des Epizooties (OIE) as a country free from foot and mouth disease (FMD) without vaccination;
- 2. the area within a radius of 30km of the premises of origin at paragraph II (b) above has been free from peste des petits ruminants, sheep/goat pox, foot and mouth disease, rinderpest and rift valley fever for the last 12 months;
- 3. the premises of origin is free from clinical or other evidence of the following OIE listed diseases to which sheep and goats are susceptible, for the periods stated:
 - contagious agalactia, for at least 6 months;
 - caseous lymphadenitis, contagious epididymitis (*Brucella ovis*) paratuberculosis (Johne's disease) and contagious caprine pleuropneumonia, for at least 12 months
 - Leptospirosis and brucellosis caused by Brucella melitensis, for at least 2 years;
 - caprine arthritis-encephalitis (CAE), for at least 3 years;
- 4. the animals for export have been isolated from all other livestock on the premises at paragraph II (c) for a period of at least 60 days prior to the date of export;
- 5. as far as can be determined, the animals for export have not been exposed to any infectious or contagious disease to which the sheep and goats are susceptible during the 60 days isolation period prior to export;
- 6. the animals for export were examined within 24 hours prior to loading for export and found to be free of any clinical signs of infectious or contagious disease to which the sheep and goats are susceptible;
- 7. on (date), being within 30 days prior to the date of export, the animals were subjected to a comparative intradermal tuberculin test, with negative results;
- 8. on (date), being within 30 days prior to the date of export, the animals were subjected to a serum agglutination test (SAT) (negative SAT means less than 30 IU/ml) for *Brucella abortus*, with negative results;
- 9. in respect of scrapie:
 - (i) scrapie is a notifiable disease in the UK and a surveillance and monitoring system for the disease is in place;
 - (ii) no case of scrapie has been confirmed on the premises of origin during the past 7 years;
 - (iii) the animals for export are not affected with scrapie and are not the progeny, sire, dam, full or half brother or full or half sister of any animal found to be affected by scrapie;
