IV Health Information

- I, the undersigned, certify that:
- a) the meat/meat products was/were derived from animals/birds which have been subjected to ante-mortem and post-mortem inspection under veterinary supervision in an officially approved slaughterhouse and found free from clinical evidence of infectious or contagious disease;
- b) the meat/meat products and/or the packaging thereof bears an official oval mark indicating that it/they has/have been obtained, processed, packaged, labelled and stored in an officially approved establishment in accordance with European Union hygiene regulations, including compliance with the microbiological criteria, and is/are fit for human consumption;
- c) the meat/meat products has/have been stored in an hygienic manner in accordance with European Union hygiene regulations so as to prevent contamination with agents known to cause infectious disease of humans or animals;

*d) IN THE CASE OF MEAT/MEAT PRODUCTS OF BOVINE, OVINE AND CAPRINE ORIGIN

- i. Bovine spongiform encephalopathy (BSE), scrapie and other transmissible spongiform encephalopathies (TSEs) are compulsorily notifiable in the European Union. An effective surveillance and monitoring system for BSE and scrapie is practised in European Union Member States in line with the current Terrestrial Animal Health Code of the World Organisation for Animal Health (OIE). Should BSE or scrapie be suspected, the affected animals are slaughtered and their carcases completely destroyed;
- ii. the meat/meat products was/were derived from animals which have been subjected to ante-mortem inspection under veterinary supervision and found free from clinical evidence of BSE and scrapie;

- *iii. cattle from which the meat/meat products are derived were not subjected to a stunning process, prior to slaughter, with a device injecting compressed air or gas into the cranial cavity or to a pithing process;
- iv. the meat/meat products does/do not contain any commodities that should not be traded (known as specified risk material under European Community legislation) as recommended in the current OIE Terrestrial Animal Health Code Chapter on BSE;
- e) European Union approved slaughterhouses/meat establishments are subjected to monitoring under the national residue monitoring plan to ensure that meat intended for trade within the European Union does not contain levels exceeding the limits permitted by European Union regulations of any veterinary medicinal product, antiparasitic agent, heavy metal contaminant, beta-agonist or any substance having a thyrostatic, oestrogenic, androgenic or gestogenic action;
- f) the transport vehicles or containers and the loading conditions of this consignment meet the conditions laid down in European Union hygiene regulations;

*g) IN THE CASE OF FRESH MEAT ONLY

the meat was derived from animals/birds which, at the time of their slaughter, were resident in a country or zone which was free of the following diseases in accordance with the OIE Terrestrial Animal Health Code:

- *i. In the case of meat of porcine origin: foot and mouth disease, rinderpest, classical swine fever, African swine fever and swine vesicular disease;
- *ii. In the case of meat of bovine origin: foot and mouth disease
 and rinderpest;

- i. the meat products were derived from animals/birds which, at the time of their slaughter, were resident in, a country or zone which was free of the following diseases in accordance with the OIE Terrestrial Animal Health Code:
 - *a) In the case of meat products of porcine origin: *foot and mouth disease, *rinderpest, *classical swine fever, *African swine fever and *swine vesicular disease;
 - *b) In the case of meat products of bovine origin: *foot and mouth disease and *rinderpest;
