EXPORT TO THE CAYMAN ISLANDS OF MEAT, MEAT PRODUCTS OR MEAT PREPARATIONS (EXCLUDING POULTRY)

NOTES FOR THE GUIDANCE OF OFFICIAL VETERINARIANS AND EXPORTERS

IMPORTANT

These notes provide guidance to Official Veterinarians (OVs) and exporters and should have been issued to you together with export certificate 3708EHC. These Notes for Guidance (NFG) are not intended to operate as a standalone document but in conjunction with certificate 3708EHC.

Exporters are strongly advised to verify the requirements of the importing country by contacting the veterinary authorities, or their representatives in the UK, in advance of each consignment.

1. SCOPE OF THE CERTIFICATE

Export health certificate 3708EHC may be used for the export of fresh/frozen meat, meat products or meat preparations (excluding poultry) from the United Kingdom to the Cayman Islands.

2. CERTIFICATION BY AN OFFICIAL VETERINARIAN (OV)

In Great Britain, this certificate may be signed by a Veterinary Officer of the Department or by an authorised Official Veterinarian (OV) appointed to the appropriate panel for export purposes by the Department for Environment, Food and Rural Affairs (Defra), the Scottish Government or the Welsh Government. In Northern Ireland, this certificate may be signed by an Authorised Veterinary Inspector (AVI) appointed as an OV to the appropriate export panel for export purposes by the Department of Agriculture and Rural Development (DARD).

OVs must sign and stamp the health certificate with the OV stamp in any ink colour ${f OTHER\ THAN\ BLACK}.$

A certified copy of the completed certificate must be sent to the Animal and Plant Health Agency (APHA) Centre for International Trade at Carlisle within seven days of signing, or in the case of Northern Ireland to DARD, Dundonald House, Belfast.

The OV should keep a copy for his/her own records.

3. OBTAINING AN IMPORT PERMIT

The exporter/agent should be aware of the requirements of the importing country particularly with respect to the requirement for an import permit.

4. Paragraphs V 1, 2 and 3 can be certified on the basis of the EU oval mark and evidence that the slaughterhouse, cutting plant, meat products plant (if applicable) and cold store are officially approved and operating in accordance with Regulations (EC) Nos. 852/2004, 853/2004 and 854/2004, as transposed into national legislation. Official Veterinarians must be conversant with Regulation (EC) No 853/2004 of the European Parliament and of the Council of 29 April 2004 laying down specific hygiene rules for food of animal origin which inter-alia lays down the requirements for transport of meat and meat products.

5. TRANSMISSIBLE SPONGIFORM ENCEPHALOPATHIES (TSE's)

Paragraphs VI 1, 2, 3 and 4 be certified on the basis that these are requirements of the TSE legislation (Regulation (EC) No. 999/2001, as transposed into national legislation), and that the UK competent authorities (Defra, the Devolved Administrations and the Food Standards Agency) ensure compliance with the legislation.

6. Paragraph VI 5 can be signed providing the bovine meat and meat products were derived from cattle slaughtered and/or processed after 31 December 2007.

7. DISCLAIMER

This certificate is provided on the basis of information available at the time and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country.
