EXPORT OF CAPRINE AND OVINE SEMEN TO THE UNITED ARAB EMIRATES

NOTES FOR GUIDANCE FOR OFFICIAL VETERINARIANS AND EXPORTERS

IMPORTANT

These notes provide guidance to Official Veterinarians (OV's) and exporters and should have been issued to you together with export certificate 7402EHC. These Notes for Guidance (NFG) are not intended to operate as a standalone document but in conjunction with certificate 7402EHC.

Exporters are strongly advised to verify the requirements of the importing country by contacting the veterinary authorities, or their representatives in the UK, in advance of each consignment.

1. Scope of the Certificate Export health certificate 7402EHC may be used for the caprine and ovine semen from the United Kingdom to the Unit Emirates

Certification by an Official Veterinarian (OV) 2.

This certificate may be signed by a Local Ve ry Inspector ood and Rural Affairs appointed by the Department for Environme ot, (Defra), Scottish Government - Rural Directorate, Welsh Government, Department for Rural Affairs, or an Authorised Veterinary Inspector (AVI) appointed by the Department of Agriculture and Rural Development Northern Ireland (DARDNI), who is an Official Veterinarian (OV) on the appropriate panel for export purposes. OVS/AVIs should sign and stamp the health certificate with the OV/AVI stamp in any colour **OTHER THAN** ure and Rural Development erinarian (OV) on the BLACK.

A certified copy of the completed certificate must be sent to the Animal Health and Veterinary Laboratories Agency (AHVLA) Specialist Service Centre - Exports - at Carlisle within seven days of signing, or in the case of Northern Ireland to DARD, Dundonald House, Belfast.

The OV should keep a copy for his/her own records.

Schedules Paragraph 1.1 refers: A separate schedule may be used to identify the animals certified. This schedule must contain the same information as required in paragraph I.1 and paragraph I.1 must be annotated that e attached schedule". Each page of the schedule must bear a page number and the health certificate reference number and must be signed, dated and stamped by the Official Veterinarian (OV).

The schedule must be stapled inside the health certificate and the OV should "fan" and stamp over the pages of the schedule and certificate. The top stapled corner of the schedule and certificate should be folded over and stamped also. Any blank spaces in the schedule or in paragraph I.1 must be deleted with diagonal lines.

5. Scrapie

Paragraph IV.10 refers: Documentary evidence of membership of the SAC Scrapie Monitoring Scheme or of the ARR/ARR prion protein genotype of the donor(s) must be presented to the certifying Official Veterinarian prior to signature. The genotyping must be either carried out at a government laboratory (VLA), or the Scottish Agriculture College (SAC) or Cellmark (where the certificate is issued by Innovis AND it clearly states in the top right hand corner that a veterinarian took the sample and mentions the address) OR the individual sheep for intracommunity trade must have a genotyping certificate issued under the National Scrapie Plan (NSP) or the Compulsory Scrapie Flocks Scheme (CSFS) by a laboratory which is/was authorised by the government to carry out genotyping under the plan/scheme. Any such genotyping certificates issued under the scheme/plan before it/they closed remain valid, but the OV must ensure that the identification of the animal as recorded on the genotyping certificate correlates with the official ear tag on the animal as recorded on the EHC; if only the electronic identification number is recorded on the genotyping certificate, then the OV must scan and check the electronic identification of the sheep to confirm correlation between the certificate, the sheep and the official ear tag number on the EHC. Unless genotyping was carried out officially under the NSP or CSFS, all blood samples for genotyping must be taken by a veterinary surgeon.

Notifiable disease clearance (form 618NDC) Paragraphs IV.1, IV.6 and IV.11 (a) refer: OVs may certify paragraphs IV.1, IV.6 and IV.11(a) on behalf of the Department provided written rom the A authority to do so has been obtained on form 618NDC NVLA Specialist Service Centre - Exports - at Carlisle o office of DARD in Northern Ireland.

7. Laboratory tests

The OV must ensure that any laboratory carrying out pre-is officially approved for this purpose by Defra or DAR out pre-export testing

In Great Britain (England, Wales and Scotland), the majority of pre-export testing is carried out at the AHVLA Laboratory, New Haw, Weybridge, Addlestone, Surrey, KTLS INE, (Tel: 01032 341111). Some tests are carried out at AHVLA Lasswade, Bentlands Science Park, Bush Loan, Penicuick, Midlothian, EN26 OP2, (Tel: 0131 445 6169). Certain specialist tests are carried out at regional AHVLA laboratories.

In Northern Ireland, the majority of pre-export testing is carried out at the Veterinary Sciences Division (V9D) Laboratory, Stormont, Belfast, BT4 3SD (tel: 028 9052 0011).

For operational reasons however, the laboratories involved may change periodically. Accordingly, the OV is advised to check with the AHVLA or VSD to determine to which laboratories samples should be sent for of VSD to determine to which importantly samples should be sent for testing. Samples should always be sent to the laboratory concerned sufficiently in advance of the export date to enable the tests to be carried out and reported. If in doubt as to the procedures for collection, the requirement for transport medium if any, dispatch of samples and the length of time a test is likely to take, the OV should seek the advice of the relevant laboratory.

Sealing of the transport container Paragraph IV.16 iii) refers: The semen must be secured within a yogenic container by a tamperproof seal applied in such a way that the container cannot be opened without breaking the seal. The number he eal must be entered at paragraph III.3 on the health on certificate.

If it is necessary to top up the container, the additional liquid nitrogen used must meet the requirements of the certificate - see paragraph IV.16 ii). Topping up should be done in the presence of an Official Veterinarian (OV) who must apply a new tamperproof seal. The OV must endorse paragraph III.3 on the health certificate with the new seal number, giving name and signature and dating and stamping the endorsement in the margin of the certificate in any ink colour other than black.

9. Disclaimer

This certificate is provided on the basis of information available at the time and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check
