IV. HEALTH ATTESTATION

I, the undersigned, official veterinarian, certify that the animals described above meet all the conditions laid down in the health attestation below:

1. GENERAL CONDITIONS

- a) *the animals originate from premises¹ where no livestock species, other than pigs, are raised. They have been reared indoors since birth and have not been fed or been in contact with household or other waste, raw meat products, milk products or milk. All feed for these animals has been stored indoors at all times;
- b) the premises of origin¹ of the animals have not been subject to restrictions and/or quarantine measures pertaining to animal diseases of concern for the importation of the species in question for the duration of their residency;
- c) *the animals intended for export were born² on the premises of origin¹, OR were born on a premises other than the premises of origin, were separated from their dams and underwent early weaning and were regrouped before the age of 21 days and reared on the premises of origin. In this case, all the premises where the piglets were born had a health status equivalent to that of the premises of origin and in accordance with all the conditions relating to premises and herds listed in this certificate;
- d) the animals were placed in pre-export quarantine premises approved by an official veterinarian of the exporting country for the necessary period - for no less than thirty (30) days - for carrying out tests required to meet Canada's import requirements. This pre-export quarantine ends with the signing of this health certificate by an official veterinarian of the exporting country, at the time of export to Canada. The animals have remained free from any signs of infectious or contagious diseases and have been free from contact with animals, products or equipment with a lower animal health status throughout the quarantine period;
- e) Under the supervision of the signing official veterinary inspector of the central veterinary service of the country of origin or the signing veterinarian designated for such purposes by the central veterinary service of the country of origin:
 - *the animals were transported without delay from the premises of origin¹ to the pre-export quarantine premises in vehicles or containers which had been cleaned and disinfected and did not have contact with any animals or equipment used on animals of a lesser health status;
 - ii. the approved pre-export quarantine premises were thoroughly cleaned and disinfected prior to the animals' entry;
 - iii. no animals of a lesser health status were introduced onto the approved pre-export quarantine premises during the quarantine period;
 - iv. no animal was removed from the pre-export quarantine premises, unless specifically authorized by an official veterinarian of the exporting country³;
 - v. all the treatments and tests associated with the conditions in this export certificate were carried out using sterile veterinary products and equipment;

vi. a declaration signed by the owner/exporter has been received by the official veterinary services of the exporting country stating that the following arrangements have been made for the transportation of the animals from the pre-export quarantine premises to the port of loading and to their final destination in Canada:

> . The animals will be transported direct from the preexport quarantine premises to the place of loading in a vehicle which has been cleaned and disinfected beforehand; . During transportation from the pre-export quarantine premises to the place of loading and shipment, the animals will not come into contact with animals of a lower health status or equipment used on animals of a lower health status;

f) The animals have been treated for parasites as follows:

EITHER

**i. within seven (7) days of export, the animals were treated for internal and external parasites with Ivermectin at a dosage of 0.3 mg/kg body weight or other treatment that is licensed and approved for that purpose by the central veterinary authorities of the exporting country;

OR

- **ii. the animals were derived by caesarian section and maintained without exposure to endoparasites and ectoparasites;
- g) all animals placed in the pre-export quarantine premises gave negative results to all the tests required for importation into Canada;
- h) the animals were examined by a veterinarian in the twenty-four (24) hours immediately prior to export to Canada (date stated on page 1 of this health certificate). The animals were in good health and free from clinical signs of infectious diseases and, as far as can be determined, have not been exposed to such diseases;
- each animal is individually indentified with an ear tag, and the number has been entered on page 1 or on a list attached to this health certificate;

2. AFRICAN SWINE FEVER

- a) the animals come from the exporting country or a zone where no restrictions have been introduced by the European Community (EC) in relation to African swine fever and have been kept in the exporting country or in this zone since birth;
- b) *the pigs have had no contact with pigs or pig products (including imported pigs or products thereof) which have been in a region where restrictions are in place in relation to African swine fever;
- c) the exporting country complies fully with all relevant EC decisions concerning this disease;

3. FOOT AND MOUTH DISEASE

a) the animals come from the exporting country or a zone where no restrictions have been introduced by the EC in relation to FMD and have been kept in the exporting country or in this zone since birth or for the last 3 months;

- b) *the pigs have had no contact with pigs or pig products (including imported pigs or products thereof) which have been in a region where restrictions are in place in relation to FMD;
- c) the pigs have not been vaccinated against FMD;
- d) the exporting country complies fully with all relevant EC decisions concerning this disease;

4. CLASSICAL SWINE FEVER

- a) the animals come from the exporting country or a zone or compartment where no restrictions have been introduced by the EC in relation to CSF for at least 3 months;
- b) *the pigs have had no contact with pigs or pig products (including imported pigs or products thereof) which have been in a region where restrictions are in place in relation to CSF;
- c) the pigs have not been vaccinated against CSF and are not the progeny of vaccinated sows;
- d) the exporting country complies fully with all relevant EC decisions concerning this disease;

e) the domestic pigs exported to Canada come from a premises¹ which is not situated in a region currently subject to restrictions because of the appearance of CSF in a population of feral pigs and which has been subject to surveillance to confirm the absence of CSF in accordance with EC requirements;

5. SWINE VESICULAR DISEASE

- a) the animals come from the exporting country or a zone where no restrictions have been introduced by the EC in relation to SVD and have been kept in the exporting country or in this zone since birth or for the last 6 weeks;
- b) *the pigs have had no contact with pigs or pig products (including imported pigs or products thereof) which have been in a zone not recognised as free from SVD;
- c) the exporting country complies fully with all relevant EC decisions concerning this disease;

6. BRUCELLOSIS

 a) the premises of origin¹ has been declared free from brucellosis by the exporting country, and:

i) *the pigs have had no contact with pigs or pig products (including imported pigs or products thereof) which have been in a zone not recognised as free from brucellosis;

ii) the exporting country complies fully with all relevant EC decisions;
