IV Health Certification:

I, the undersigned, certify that the meat/meat products described above meet the following requirements:

- a) the said products were derived from animals which were subjected to ante-mortem and post-mortem inspection with satisfactory results and found to be free from signs of notifiable diseases, including foot and mouth disease;
- b) the meat/meat products described above were derived from meat which was obtained under the conditions governing production and control laid down in European Union (EU) legislation laying down hygiene rules for food of animal origin and its official controls and that it is oval marked as fit for human consumption. In the case of fresh red meat of non-EU origin this was imported under the conditions governing production and control laid down in Council Directive 72/462/EEC;

- c) the meat/meat products described above have been dressed, prepared and packed under hygienic conditions in accordance with regulations at present in force in Great Britain;
- *d) in the case of meat products, the meat products were prepared in establishments approved for export to the European Union and are fit for human consumption;
- e) the pigmeat/pigmeat products and the animals from which the pigmeat/pigmeat products are derived have not been in any region infected with foot and mouth disease (FMD) during the last 6 (six) months prior to export;
- f) the United Kingdom has been free from rinderpest for the last 6 (six) months;
