IV Health Information

I, the undersigned Official Veterinarian, certify that the consignment of meat and/or meat products described above meets the following conditions:

- (a) the country of origin or the administrative territory of the country of origin of the pigs from which the products were derived has been free of foot and mouth disease (FMD), anthrax, African swine fever, classical swine fever (hog cholera) and swine vesicular disease for the twelve (12) months prior to the date of export;
- (b) the pigs, from which the pork meat or products were derived, originated from an accredited farm under the continuous supervision of the veterinary authority of the United Kingdom and/or the EU Member State of origin;

- (c) the slaughtered pigs, from which the pork meat or pork products were derived, originated from farms that were officially free from swine vesicular disease and no case of reportable infectious or contagious pig diseases have been diagnosed or confirmed at the farm(s) for the twenty eight (28) days prior to the shipment of the pigs for slaughter;
- (d) the pigs, from which the pork meat or pork products were derived, have been slaughtered and processed in a slaughterhouse which has been approved for export by the Department of Veterinary Services (DVS) Malaysia and has been under continuous supervision of the veterinary authority of the United Kingdom;
- (e) the pork meat or pork products were derived from pigs that have been subjected to ante-mortem and post-mortem inspection and were found to be healthy and free from any clinical sign of infectious or contagious disease at the time of slaughter/processing;
- (f) the pork meat or pork products have been processed, packaged and stored under sanitary conditions and do not contain any preservatives, colouring matter, residue or any foreign substance or harmful material injurious to health and every precaution has been taken to prevent contamination during processing, packing, storing and handling prior to export;
- (g) the pork meat or pork products destined for export to Malaysia are safe, wholesome and fit for human consumption;
- (h) the refrigerated vehicle/container used for the transportation of the frozen/chilled pork meat or pork products meets the hygiene conditions currently in force in the United Kingdom.
